Working as a team, you will be asked to analyse a coinvestment opportunity and write an investment review paper with a recommendation on whether or not to invest.

The best team from each school and the first runner-up will be invited to present their findings to the Hermes GPE team, followed by dinner in London. The winning team will be offered the opportunity to interview for a summer internship with us beginning in June 2017.

## **Essential information**

- The competition is open to Oxford Saïd Finance Lab students (MBA MFE MLF programmes) and LBS PE/VC Club members (MBA and MiF programmes)
- Students to work in teams of three people
- Hermes GPE will supply co-investment information based on real examples for candidates to complete the task
- Shortlisted candidates must be available on 25 January to travel to London to present to their work and attend dinner in the evening

### The challenge

We would like you to review a potential co-investment opportunity into a public-to-private transaction (target company to be shared closer to the date) alongside a private equity fund (General Partner) of your choice, with a view to making an investment recommendation to Hermes GPE's Investment Committee.

The format should be a Powerpoint presentation (maximum 10 slides) and supporting Excel model covering the following headings:
