IESE Private Equity Competition

Competition Format:

- Registered teams will receive a case by **February 14th, 2020** and will be given until **March 16th, 2020** to analyze the company and craft a recommendation presentation
- At IESE, each team will meet with the different parts involved in the transaction in 30 minutes meetings to shape and structure the final recommendation
- Pitch to the judges will be comprised of a compressed presentation (15 min.) and a Q&A session (15 min.)
- Final decision, feedback, and prizes
- Breakfast, appetizers, lunch, and dinner provided by IESE
